



WILDLIFE MONITORING AND CONSERVATION POLICY

1. Our hotel is committed to being aware of and fully complying with all applicable local, national, and international regulations and guidelines regarding wildlife monitoring and interactions with wildlife.
2. Our staff will be trained to protect wildlife and ensure sustainable interaction with wildlife in all hotel activities. This training will be regularly updated and delivered in cooperation with local conservation organizations and experts.
3. Our hotel is committed to supporting projects that aim to protect and sustain natural habitats of wildlife. These may include habitat restoration, the creation of wildlife conservation areas, and the sustainable management of local ecosystems.
4. We will provide our guests with informative materials on wildlife conservation and respecting the natural environment, and we will inform them about relevant local guidelines and regulations. We also encourage our guests not to disturb, endanger, or pollute wildlife habitats.
5. Our hotel will take all necessary measures to prevent activities and practices that could disturb wildlife and will act in accordance with local regulations. This policy reflects our hotel’s commitment to protecting wildlife and promoting sustainable tourism. All staff members and guests are responsible for complying with this policy and are expected to actively contribute to our wildlife conservation efforts.
